Prevent!

For PREVENT!, a community coalition and government organization working to decrease marijuana use by teens in our community, the LCC project team developed a point of purchase campaign designed to keep marijuana out of the hands of youth. The LCC team participated in message development with the coalition workgroup, identified retailers interested in participating and created an outreach plan for marijuana retailers to distribute 4,000 postcards with messaging about protecting young minds, securing cannabis and keeping it safe. CREDC
