



## Leadership Clark County Regular Enrollment Application

**Mission:** The Mission of Leadership Clark County (LCC) is to inspire and engage leaders by providing experiences and opportunities to build a strong community.

**Application Instructions:** Please provide all the information requested in the application and return the signed Appointment Agreement. Partial or incomplete applications will not be considered.

**Regular Enrollment Deadline:** Early applications are highly encouraged due to a limited class size. Up to 36 participants are accepted each year, with the class typically filling by June 1<sup>st</sup> for the upcoming class year.

**Tuition:** Tiered tuition is offered at three levels ranging from \$2950 - \$3875. Pay what you can, no questions asked. Tier 1: **\$3875** Tier 2: **\$3400** Tier 3: **\$2950**

**Tuition is non-refundable once an applicant is accepted.** Class members are expected to pay the chosen tuition level in full, or make arrangements for a payment plan, no later than **September 1<sup>st</sup>**. Applicants will not be allowed to participate unless tuition is paid in full, a payment plan is established, or alternate payment arrangements have been approved in writing by Leadership Clark County.

**Scholarships:** In addition to tiered tuition, LCC offers additional scholarship support. Support is contingent on funding availability on a case-by-case basis. Please see the scholarship section for details.
